2022 was the year of change for FOCAS and Lord's Gym Ministries. What a ride. Most rewarding was the completion of a 6-year long renovation project of our Family Activity Center (FAC) in Price Hill. We reopened in mid-July to a very excited community. Comments truly glorified God with what He did! Please know that we would love to show you the place. While this was a significant milestone, there were other moves of God too.

Besides being blessed with a wonderful newly renovated facility, the Lord in His omnipotence orchestrated bringing us more competent and Godly staff. They are deeply committed to serving the Lord and all have a great diversity of experiences, training and talents. With this staff, we have launched sports and after school activities that are engaging about 150 youth from Price Hill. Because many participate in multiple activities, it is more like 300 youth and their parents/caregivers.

Upon reopening, God used the FAC to make room for more partnerships and

collaborations such as Addiction Services Council, UMADOP, Cincinnati Recreation Commission, IDEA and Cincinnati Public Schools, Urban Outreach, SportsReach, and Children's Hospital. Without compromising the Gospel, we have mutual goals of seeing our friends helped in practical ways. We hope to continue partnerships such as these, that support the health and wellness or life advancement of our friends.

God has been very gracious in sending us committed volunteers and faithful churches. As the FAC becomes more established in 2023, we will need more volunteers and church relationships to serve the community, as well.

With the start of our 22/23 basketball season, we launched our SEL (Social, Emotional, Learning) assessment program to quantifiably show the effectiveness of our programs using this Nationally Recognized assessment tool. We are getting the process fully implemented but directionally the





data that we have been able to collect shows a meaningful impact. As we get the SEL process fully implemented,

we will report on the outcomes.

Lastly, our board concluded that the Lord's Gym located on the Campus of City Gospel Mission, (1211 York St.), was not attracting the profile of young men caught up in destructive lifestyles as it did when located in its previous locations in Over-the-Rhine. Most of those attending the York St. Gym were employed, stable, older members, or those attending City Gospel's Exodus Program. The Gym space and equipment will continue to be used by the men of the Exodus Program while we seek the Lord's direction as to where we should relocate the Queensgate Lord's Gym. We met with Cincinnati Police Department to evaluate other neighborhoods struggling with violence, crime, and drugs. Please keep this in your prayers.

In retrospect, I continue to be humbled and grateful for God's goodness and faithfulness as we continue in 2023 in anticipation of our 30-Year Anniversary of the Lord's Gym Ministries. I will also recognize 22 years with the ministry and my 10th year as FOCAS' Executive Director and President.

These 5 SPECs are captured under the categories of: Spiritual Advancement and Life Advancement of our Dashboard.







